## MARKET COMMENTARY

### Bank, oil stocks lead rally

Bulls were back with a bang as the key benchmark indices surged for the second straight day on firm global stocks after China signalled support for the euro zone. Bank and oil shares led the rally.

The RBI expects India's economy to expand 8% in the year ending March 2011 (FY 2011) with an upward bias, assuming a normal monsoon this year and sustenance of good performance of the industrial and services sectors on the back of rising domestic and external demand. The RBI at its annual policy review on 20 April 2010 said it will continue to monitor macroeconomic conditions, particularly the price situation closely and take further action as warranted.

The BSE Mid-Cap index rose 0.93% and the BSE Small-Cap index rose 0.77%. Both the indices underperformed the Sensex. All the sectoral indices on BSE rose. Banking sector index Bankex (up 2.55%), BSE Auto index (up 2.1%) and Oil & Gas index (up 2.09%), outperformed the Sensex. BSE Realty index rose 1.7% and matched Sensex's gains. BSE Consumer Durables index (up 0.63%), IT index (up 0.75%), Healthcare index (up 0.85%), Metal index (up 1.41%), Power index (up 1.43%), PSU index (up 1.51%) FMCG index (up 1.55%) and Capital Goods index (up 1.63%) and underperformed the Sensex.

The market breadth, indicating the overall health of the market, was strong. The breadth strengthened as trading progressed. On BSE, 1669 shares advanced as compared with 1128 that declined. A total of 89 shares remained unchanged.

The total turnover on BSE amounted to Rs 3809 crore, higher than Rs 3234.39 crore on Wednesday, 26 May 2010.

From the 30 share Sensex pack, 26 stocks gained while only 4 of them slipped.

### D B Corp's Q4 net up 56% to Rs 37 cr in FY10

Hindi newspaper publisher D B Corp yesterday said its consolidated net profit grew by 56.54 per cent to Rs 36.71 crore in the fourth quarter ended March 31, 2010, over the corresponding period a year ago. The company had a consolidated net profit of Rs 23.45 crore in the same period last fiscal, D B Corp said in a filing to the Bombay Stock Exchange (BSE).

### Essar Shipping FY10 net up 22%; RN Ruia resigns as VC

Essar Shipping Ports and Logistics yesterday posted a growth of 21.46 per cent in its consolidated net profit at Rs 93.77 crore for the year ended March 2010, against the same period last year. The company had a consolidated net profit of Rs 77.2 crore in the same period of the previous fiscal, Essar Shipping said in a filing to the Bombay Stock Exchange (BSE).

### Tata Motors to expand JLR footprint in China

The country's largest auto company Tata Motors yesterday said it is planning to enhance the presence of the Jaguar Land Rover (JLR) brand in China. "We are planning to increase our JLR presence in China as we are expecting that a considerable volume growth will come from there in the coming years," Tata Motors Group Chief Executive and Managing Director Carl Peter -Forster told reporters here yesterday, while announcing the annual results for the 2010 fiscal.

### Surya Pharma to raise Rs 3 bn for expansion plans

Surya Pharmaceutical yesterday announced that its board of directors has decided to raise up to Rs 3 billion or equivalent USD from domestic or international market. The aforesaid funds would be raised by issue of permissible securities for funding its new projects, expansions, diversifications, acquisitions, other business expenses and to augment working capital requirements.
